2.	Am I eligible for GTET as per my acquired qualification?	The candidate should self-ensure his/her eligibility before applying and shall be personally responsible in case he/she is not eligible to apply as per the given eligibility criteria. Please read the GTET Information Bulletin carefully.
3.	After qualifying for the GTET am I eligible for getting the job?	Qualifying GTET would not confer a right on any person for Recruitment /Employment as it is only one of the eligibility criteria for appointment.
4.	If one qualifies GTET, will SCERT/DoE provide me a job?	SCERT is an Examination conducting body only. Providing job/employment does not fall under its jurisdiction.
5.	What is the number of attempts a candidate can avail for GTET?	Till now there is no limit on the number of attempts for appearing on GTET.
6.	What is the validity period of GTET certificate?	The validity period of the GTET qualifying certificate for an appointment unless otherwise notified by the government would remain valid for life.

18.	I have different names in my SSC, HSC and Aadhar card. What name should I register for GTET?	You may register with the name in your Aadhar card if it is an updated one. You have to prove your Identity at the exam centre through your declared ID that is Aadhar and the Admit card to be issued by SCERT. Note that no change will be accepted in name or any other data after 10th February 2023 and if you pass the Eligibility Test the certificate will be issued in the same name as it appears on your Admit card. At no point of time after the GTET-23 name change requests will be entertained. The onus of proving your Identity and your current name or multiple name lies with you. SCERT will issue a one-time certificate with the name you register on the GTET portal and the name that appears on your Admit card.
